BUDGET ADDENDUM

n the final week of the 2021-22 California state legislative session, several changes were made to the 2022 Budget Act. Most notably, the Budget Act set aside approximately \$13.5 billion for investments to mitigate climate change including wildfire and forest resilience, drought response and resilience, energy reliability, extreme heat, nature-based solutions, and zero-emission vehicles. These funds were allocated to specific strategies in the final week of the session. In addition, actions were taken to fund the Community Assistance, Recovery and Empowerment (CARE) Court, extend COVID-19 supplemental paid sick leave through the end of the year, and respond to the monkeypox state of emergency.

CLIMATE INVESTMENTS

The 2022 Budget allocates \$39 billion over five years toward climate resilience and integrated climate, equity, and economic opportunity across the state's budget to mobilize a coordinated government-wide response to the climate crisis. Combined with \$15 billion that was included in last year's budget, a total of \$54 billion has been allocated to make historic investments in the expansion of zero-emission vehicles, climate innovation and opportunities for quality jobs. The Budget integrates climate actions across program areas with additional funding to support the state's climate goals in transportation, housing, health, schools, and job training.

WILDFIRE AND FOREST RESILIENCE PACKAGE

The Budget includes \$1.3 billion over two years to continue strengthening forest and wildfire resilience statewide, including \$630 million allocated during the last week of session. The Budget also includes significant new CAL FIRE staffing and fire protection operational enhancements to expand the state's wildfire response capacity. Combined with early action taken in 2021 and the 2021 Budget, \$2.8 billion has been dedicated to wildfire and forest resilience in the last two years. An additional \$674.1 million in 2022-23 will add 1,350 new positions and expand fire crews, air attack operations, and provide for additional relief for CAL FIRE staff to meet the demands of wildland firefighting in a changing climate.

DROUGHT RESPONSE AND RESILIENCE PACKAGE

The Budget includes \$3.6 billion over four years for immediate drought support and long-term water resilience, including \$2.3 billion that was allocated during the final week of session. Including allocations made in the 2021 Budget, a total of \$8.7 billion has been dedicated to support drought resilience and response. The Budget also includes \$75 million to support grants to farming and related businesses negatively impacted by the drought.

ENERGY INVESTMENTS

The Budget includes important investments to support clean, reliable, and affordable energy. The August investments build on \$4.3 billion of investments made in June with another \$3.6 billion, for a total of almost \$8 billion.

In addition, Chapter 239, Statutes of 2022 (SB 846) provides, subject to appropriation, \$1 billion over three years beginning in 2023-24 for a Clean Energy Reliability Investment Plan.

ZERO-EMISSION VEHICLE INVESTMENTS

The Budget allocates \$6.1 billion over five years to decarbonize California's most polluting sector and improve public health by accelerating the state's transition to zero-emission vehicles with a focus on communities that are most impacted by air pollution. This includes \$3.5 billion that was allocated during the final week of the legislative session. Combined with funding allocated in the 2021 Budget, \$10 billion has been dedicated to zero-emission vehicles.

HEALTH

COMMUNITY ASSISTANCE, RECOVERY AND EMPOWERMENT (CARE) COURT

The Budget provides \$88.3 million General Fund for CARE Court. Specifically, this includes \$57 million in one-time start-up funds to support county planning and preparation activities. Of the \$57 million, \$31 million is for county planning and preparation activities, including hiring, training, and developing policies and procedures, and to support information technology infrastructure costs. The remaining \$26 million is for the first set of counties that will begin implementing CARE Court for planning and preparation activities. These counties are Glenn, Orange, Riverside, San Diego, Stanislaus, Tuolumne, and the city and county of San Francisco.

Another \$25.2 million is included for the Department of Health Care Services and the Californian Health and Human Services Agency to support the implementation of the CARE Act, and \$6.1 million to the Judicial Branch for program administration, coordination of self-help centers, and legal services.

RESPONDING TO MONKEYPOX

The Budget includes \$41.4 million General Fund to support monkeypox efforts at both the state and local levels. Of this amount, \$1.5 million General Fund will be available for grants to community based organizations to support clinics for monkeypox vaccinations. Additionally, provisional language directs Department of Public Health (DPH) to allocate and shift, between state operations and local assistance, approved monkeypox resources in consultation with local health jurisdictions and authorizes DPH to use existing General Fund in the department's budget to support monkeypox emergency response efforts.

COVERED CALIFORNIA SUBSIDIES

The Budget initially appropriated \$304 million of state funds (Health Care Affordability Reserve Fund) as a contingency to subsidize health premiums in the event the federal American Rescue Plan Act (ARPA) subsidies were not extended. These subsidies were set to expire in 2022. Over the summer, President Biden signed the federal Inflation Reduction Act, which extended through 2025 federal premium subsidy assistance at the same levels provided previously under ARPA. The \$304 million contingency funds are no longer needed for this purpose and will remain in the Health Care Affordability Reserve Fund and may be used for future subsidies beyond 2025.

SUPPLEMENTAL PAID SICK LEAVE

The Budget extends the sunset date for COVID-19 supplemental paid sick leave from September 30, 2022 to December 31, 2022, allowing employees to continue to access up to 80 hours of supplemental paid sick leave.

Additionally, the Budget allocates \$250 million for the California Small Business and Nonprofit COVID-19 Supplemental Paid Sick Leave Relief Grant Program to provide grants to eligible small businesses and nonprofits of up to \$50,000 to reimburse costs incurred for COVID-19 supplemental paid sick leave. Provisional language allows up to an additional \$70 million to be appropriated to support this program, if General Fund savings are achieved due to increases in federal funds becoming available to support other programs.

VICTIM COMPENSATION AND SERVICES

The Budget includes \$75 million ongoing General Fund beginning in 2024-25, if the Director of Finance determines that General Fund revenues over the multi-year forecast are available to support it, to implement significant statutory changes to expand the Victim Compensation Program and compensation for erroneously convicted individuals, as well as to eliminate the restitution fine. The Budget makes statutory changes to expand compensation to support a crime victim's loss of income, increase victim compensation benefits, and prohibit a victim from being denied assistance based on failure to cooperate with law enforcement at the scene of the crime or because they delayed reporting a crime. The Budget also includes \$23 million one-time General Fund to be spent over three years to support trauma recovery centers, and \$3 million one-time Restitution Fund to conduct an outreach campaign to raise awareness of statewide victim support services.
